Ron Bretta brought his latest, most detailed giant scale FW190 to the March meeting. For his efforts over the last 1.5 years he was presented with the Builders Award trophy by Pres. Mark. He gave a briefing on what went in to the making of the WW2 German fighter. He said it was built from a short kit by Roy Valliancourt, laser cut, all balsa and covered with glass fiber. He then surface detailed the entire plane with panel lines and rivets followed by Hobbypoxy paint in the correct color and markings. It weighs 31 lbs and did not require any extra weight for balance. He used a Zenoah GP80 gas twin for power, flaps and has retracts by Sierra. He answered questions for the rest of the evening—one in particular: what was the hardest part of all? His response: avoiding “hanger rash” when moving the large model around his workshop!

# Hampshire County Radio Controllers, Inc. • Business Meeting, March 5, 2015

## MINUTES:

The meeting was called to order at 7 p.m. by Pres. Mark Mundie who asked for the roll to be called. Twenty-one members reported present with several spouses of members attending as well. Reading of the prior meeting minutes was waived by voice vote. M/S/P A question arose re the waiving of the minutes. (Note: to save time it is customary to waive the reading when they are published in the newsletter.) Next, Ron Paul gave the monthly financial report which was detailed and included a report on annual dues collections to date. His report was accepted as read. M/S/P

**Old Business:** Dave Sherman and Pete Cincotta gave a short briefing on a meeting they recently attended chaired by member, Prof. Paul Voss of Smith College. This led into a general discussion re drones, model aircraft, the FAA and the involvement of our AMA in pending legislation. The rule making is in a comment period at present with many issues still unresolved.

Andre reminded us to keep in mind that he has club shirts available and that the vendor can provide really good quality embroidery on jackets, shirts, etc. at a reasonable price.

Dave Lampron asked for more project ideas for the Field Clean-up day in April, in addition to the regular tasks that are completed each year. Bobby O. said he would cook for the crew as in the past. Ed Kopec thought we should build safety barriers from some of the metal removed from the racing cages that are stored on site. Also, at this time more ideas were exchanged on the need to keep a watchful eye on the spring runoff of the Ct. River to prevent damage to any of our equipment.

Discussion then went to the upcoming airshow in May at Westover ARB. Some of the details were outlined again by Ed. Kopec with a strong request for help with organization. Many of the members said they would be willing to participate, bring airplanes and be there either one or two days. Dave Lavigne offered to help with the coordination/planning.

**New Business:** D. Lampron Asked for an opinion on the request for HCRC to participate with a demonstration/static display at the annual Granby Charter Day event in June. Discussion followed with questions about crowd safety and HCRC members willing to participate. Members should contact any one of the club officers if interested.

Ron Paul has secured the date of December 3rd for our Christmas Party at the VFW. The date is our regularly scheduled meeting date. He has volunteered to run an event similar to what the members enjoyed in the past and to include awards, good food and music. More details will follow.

Meeting adjourned at 8 p.m so that we all could talk to Ron Bretta about his FW190.

## DRONES

On Wednesday, March 4, 2015, Peter Cincotta and I attended a seminar at Smith College in Northampton concerning the FAA's proposed regulation on drones. The seminar was sponsored by Smith College and presented by Paul Voss, whom many of us know as a club member. The target audience for this meeting seemed to be people who are most concerned with the privacy aspect of drones.

The seminar raised some very interesting questions: what is the proposed legislation targeting; what are the new definitions of 'navigable airspace'; and what impact will the proposed rules have on hobby and commercial use of drones? One interesting point made was that, until recently, 'navigable airspace' was loosely defined as airspace down to tree top level. Without passing a law, the term has been re-defined as airspace all the way to the ground. This could have vast implications for all of us, private citizens and hobbyists alike.

However, as far as model hobbyists are concerned, little has changed. We are not being targeted. A few questions have arisen concerning our proximity to Northampton

Airport and any requirements for us to report our operation to the airport. This matter is best left to the AMA for further clarification.

There is a comment period in which anyone can make a comment or recommendation concerning any proposed government regulation. When we know more about the impact of this proposed legislation it is strongly recommended that all of us submit our comments and concerns. The FAA really does listen.


