# HCRC Meeting Notes for the Thursday, January 4<sup>th</sup>, 2024 Business Meeting

Reading of the minutes from the previous month was waived.

Club finances for the month of December were reported and approved.

The Executive Committee and Search Committee meet on a weekly basis. We will rent and then purchase the land next to our current property. We are purchasing five acres extending from the road to the river. The deal is \$1600 per year to rent the land for the next two years and then purchase the five acres for \$90K.

We will fly off a runway that is currently on the parcel that we own until the rental land has been put into shape for air operations.

We will be attempting to lease the club parcel on the other side of Honeypot Road to a farmer. We may eventually sell the parcel to help finance the purchase of the new runway.

We are working on fundraising to support this land purchase:

Go Fund Me – almost ready to go live. We will alert the club when it is live and ask everyone to alert their family and friends and ask them to donate!

Selling Land Shares like what was done ~20 years ago to purchase the land across the street from the field – We are now ready to start selling land shares. Please consider purchasing land shares to support this club initiative. Each share is a \$100 commitment and has a 5 year maturity period.

We will be having some work parties soon to cut back brush and improve the new airstrip. The gate is currently being left open for anyone, member or not, to take firewood from the recent tree removal.

Membership dues for 2024 are due at the February business meeting.

The New Year's Day Fly-In was held and several people attended and flew planes and a helicopter.

We do not have a Quorum for voting in a new executive board. We need people to show up to the meetings in order to have the quorum required to vote in a new executive board. The current nominations are:

#### **REMINDER FOR 2024 MEMBERSHIP DUES**


